Waiver and Release

The undersigned, on behalf of the Rider identified above (“Rider”), acknowledges, appreciates, and agrees to the following conditions. I represent that I am the parent or legal guardian of Rider, or I have obtained permission from the parent/legal guardian of Rider to execute this agreement on their behalf. I hereby acknowledge that there are certain risks and dangers inherent to indoor cycling and exercise equipment/facilities. I understand that indoor cycling at Clementine is a more vigorous and strenuous workout than riding a bicycle outside or riding an indoor stationary bicycle on my own. In consideration of Rider being allowed access to Clementine’s classes, equipment, and facilities, in addition to the payment of any fees or charges, I hereby agree to the following: 1) I and Rider will assume full responsibility and risk for any and all injuries or damages Rider sustains or aggravates in connection with their use of Clementine's classes, equipment, or facilities; 2) I and Rider hereby waive, release, indemnify, and forever discharge Clementine, its officers, directors, members, employees, representatives, instructors, affiliates, and all others from any and all liability, responsibility, claims, causes of action, costs, expenses, or rights from injury or damages to Rider, myself or any personal property resulting from Rider's participation in and use of Clementine's classes, equipment, and facilities; and 3) I represent and certify that Rider has no medical or physical condition, nor any disabilities which would prevent them from participating in Clementine's classes or using its equipment and facilities, doing so would not put Rider in physical or medical danger, nor has Rider been advised by a medical professional not to participate in such exercise and/or activities. Clementine hereby has advised both me and Rider that should Rider have such a physical or medical condition Rider should not participate in such exercises and/or activities. Should a Clementine representative determine that Rider will be at physical or medical risk by using its classes, equipment, and facilities, I agree that they may deny Rider access to same.

Rider Conduct

I agree that Rider and myself shall comply with all written rules, posted signs, verbal instructions, and usual/customary terms and codes of conduct. Should I and/or Rider observe any violations or such rules/instructions, or observe any conduct by an instructor or participant which violates such rules/instructions, or should I and/or Rider observe any hazards to person or property, or any deliberate acts of damage to persons or equipment, I and/or Rider will immediately bring the violation, conduct, or condition to the attention of a Clementine representative. Should I and/or Rider fail to follow such rules/instructions I take full responsibility for any and all damages to person or property resulting therefrom. I agree that both Rider and myself are familiar with the use of Clementine's classes, equipment, and facilities, and that should I and/or Rider have any questions regarding such, I and/or Rider will immediately speak with a Clementine representative before further proceeding.

I have read this form in its entirety, including provisions for waiver of liability, assumption of risk, and indemnity agreement, I fully understand its terms and conditions and understand that I am giving up substantial rights, including my and Rider's right to sue. I acknowledge that I am signing this waiver freely and voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law. I hereby certify that I will explain all pertinent terms, conditions, and rules to Rider and will not allow Rider to participate unless Rider fully understands such terms and conditions.
